# NEWBURYPORT CHARTER COMMISSION COMMUNITY SURVEY 2010

In the November 2009 election, the citizens of Newburyport overwhelmingly approved a review of the city charter. The last year the charter was revised was 1919.

In service for just two months, The Charter Commission is pleased to be able to use the census mailing as a means for distributing this brief survey.

We greatly appreciate your input as a Newburyport citizen. You can make a copy of the survey for each voting age household member. Additional copies of this survey are available from the office of the City Clerk.

Much of our current charter is out of date, with references to laws that no longer exist. In places, it contradicts itself, and is cumbersome in use. The Charter Commission will gather information from other communities, examine the structure of their government, and consider what works and what does not.

We will utilize that research, analysis and input to rewrite our current charter, and recommend a structure of government for the voters of Newburyport to consider as a ballot question in November 2011.

Before that vote, the Commission intends to provide many opportunities for you to learn, ask questions, and give feedback. Through this survey, you can provide the Commission with your ideas and opinions about how our current governance model works. It is also an opportunity for you to share your desires and/or expectations about the results of our review effort.



## NEWBURYPORT CHARTER COMMISSION COMMUNITY SURVEY 2010

#### PROCESSES FOLLOWED TO ENTER AND ANALYZE SURVEY DATA

- I. General information: There were 8,477 surveys distributed, and 2,954 collected with responses for a response rate of 34.8%. (Note: A handful of surveys were submitted after having been duplicated by receivers. These are not included in the distributed count.)
- II. Batches of 100 surveys were formed, which excluded any surveys which were returned but which were blank.

#### III. Data Entry

#### A. Numerical Data

- 1. The survey questions to be analyzed quantitatively were coded as described in the accompanying *Survey Coding Instructions* document. This coding included assigning a four-digit ID number to each completed survey.
- 2. Prior to numerical data entry, all coding was checked by at least one other person.
- 3. The numerical data entry process followed the steps outlined in the *Survey Numerical Data Entry Instructions*, also included herein. All data entered was checked by a team of two, with one person reading aloud the codes entered on the survey to ensure they matched the typed in information.

#### B. Qualitative Data

1. The process followed the description provided in the *Survey Qualitative Data Entry Instructions*. All entries were checked by at least one other person.

#### IV. Data Analyses

#### A. Numerical Data

- 1. Data entered in the various Excel spreadsheets was merged, with random checks again performed to ensure accuracy of both coding and data entry.
- 2. Numerical data was analyzed using SPSS (Statistical Package for the Social Sciences). Frequency tables and bar charts were prepared.

#### B. Qualitative Data

1. Respondents' comments were combined by question. All comments were then analyzed by question to determine if any groupings or themes emerged. The comments were then coded by theme and sorted. The tables included herein show the themes used to group respondent comments. Theme decisions are a matter of judgment. Different and/or additional themes may suggest themselves after a review by Commission members, particularly because the members have great familiarity with Newburyport and the city workings.

#### NEWBURYPORT SURVEY RESEARCH PROJECT Survey Coding Instructions

#### General information

- For each stack of surveys given for coding, 100 surveys have been counted. The range of ID numbers to be assigned is given for each stack. If you find that you have more than 100, and therefore go over the ID number range OR if you have too few and need more to assign all of the numbers in the range, please see one of the supervisors.
  - Each survey has questions for which respondents were asked to provide either a rating, which can be represented by a number, or a written response.

#### Coding

- 1. First, assign each survey a unique 4 digit ID number, beginning with the first number of the ID number range for the stack.
- 2. Each survey will then need to be coded in preparation for the numerical data entry. Coders will use a **red pen** and write a code for each question in the right hand margin.
  - A. For the first set of questions with a rating scale (Q's 1, 2, 4, 5, 6, 7, 8, 9, and 11), write the selected rating in red in the margin. All "DK" ratings will be coded as a "6."
  - B. Questions 3 and 10 will be coded as a "0", no matter what is circled.
  - C. Questions under Civic & Demographic Data will be coded as follows:
    - 1) How long have you lived in the city (please check one)?

After a survey is coded and the coding is proofed, it is ready for data entry.

Data Entry
1. First, open the Excel template that has been developed for this data entry. File name is "Newburyport template" and is in the folder
2. Immediately save the file with a new name corresponding to the ID numbers for the group of surveys you are working with. E.g., if you are working with ID number 0101-0200, name the file "Newburyport 0101-0200." Save the file in folder
3. In the first column of the Excel file, enter the ID# assigned to the survey.
4. Then enter the numbers from the "coding columns" (numbers written in red).
5. Make sure you save often!
6. When you are finished with the group of 100, save the file, then close.

8. You may then continue with the next batch, always starting by opening the template. Never write over a file that

### Survey Qualitative Data Entry Instructions

#### General information

After the numerical data has been entered for a survey, it is ready for the qualitative data entry. This refers to the entering of any comments that were made on the survey.

#### **Data Entry**

- 1. Within each folder of 100 surveys, those surveys where written comments were provided have been separated and grouped on top. Check the surveys NOT in this group to make sure all comments were found.
- 2. As you begin working with a survey, check to see where any written comments have been provided.
- 3. You have been given four Word file templates, corresponding to the four questions on the survey which called for written comments (items 3, 10, CDD (4), and the general comments question).
- 4. For items 3, 10, and CDD (4), open the Word file specific to the question, then save it with a new name corresponding to the ID numbers of the group of surveys you are working with, for example, "Survey Question 3 0001-0100."
- 5. On the template for the question, enter the ID# of the survey containing the comment, and then type in the comment. The last column entitled "Contact Info." (stands for Contact Information) is used only if the survey respondent offered their contact information. If they did, simply type in "Yes."
- 6. The back side of the survey contains a place for general comments. If any comments are made there, enter them on the general comments Word file. Follow the same instructions in #4 and #5 above regarding file naming and Contact Information.
- 7. If a respondent wrote in a comment next to any item OTHER than 3, 10, CDD (4), and the one for general comments, type that comment in the general comments file. However, in these cases, in the column entitled "Other Spec. Ques." (stands for Other Specific Question), also enter the question number where that response was written. You do not need to write in a question number if the response was given for the general comments question. Follow the same instruction in #5 above regarding Contact Information.

## 8. Make sure you save to your flash drive often!

- 9. When you are finished with the surveys from the particular group of 100, print out the files where you have entered comments. Read the comments aloud to another worker as a proofreading step. Clearly mark any corrections on the printout.
- 10. Bring the flash drive to either of the two supervisors, along with the survey forms and the printout with any corrections to be made.
- 11. You may then continue with the next batch, always starting by opening the template. Never write over a file that has been saved with data!
